Conditions of Use Policy:

- 1. Use of the adventure playground should be always under the supervision of an adult group leader (over 18yrs).
- 2. All leaders of units/groups using the adventure playground must follow the Conditions of Use policy and the guidance set out below.
- 3. Users other than Girlguiding members should ensure they comply with their own activity policy requirements of their organisation.
- 4. The supervising adult should check all equipment on the playground before use to ensure that there are no signs of damage to any piece of equipment, and any identified damage should be reported to the warden and that piece of equipment not used.
- 5. The supervising adult should check to ensure no harmful or dangerous items have been placed in the adventure playground area, if found, the items should be removed, or the area should not be used. The issues should be reported to the warden so they can deal with it.
- 6. Users should have suitable covered footwear on when using the adventure playground.
- 7. For the <u>Cargo Net</u> element, the supervising adult must ensure that users only climbing along the net and not over the top.
- 8. The Adventure Playground is constructed from wood and rope, which naturally becomes slippy in wet conditions. The supervising adult is responsible for determining if the playground should be used in wet or damp conditions. The playground should not be used in frosty or snowy conditions.

Weather conditions	Users	 Equipment should not be used when underfoot conditions are very wet, frosty, or snowy causing hands and feet to slip. Adult supervisor to make this decision. 	Low	No	November 2023 Site Services Rep
Equipment failure	Users	 Supervising adult to visually inspect the playground equipment before use. Monthly visual inspection by a member of the Management Committee to identify any equipment failures or damage. Annual inspection by RPII Inspector. 	Low	No	November 2023 Site Services Rep
